LOCAL RESOLUTION 17 AN ACT ENCOURAGING THE UNC CHARLOTTE BOARD OF TRUSTEES TO ENDORSE THE CREATION OF A NCAA DIVISION I FOOTBALL TEAM

- **WHEREAS**, the University of North Carolina at Charlotte is the 4th largest institution in the University of North Carolina, and is one of few universities of its size without a collegiate football team; and,
- **WHEREAS**, the University of North Carolina at Charlotte is dedicated to quality research and education, and remains committed to providing an education that's affordable and accessible; and,
- WHEREAS, the Student Government Association of UNC Charlotte conducted a Spring 2007 Official Football Poll, wherein of the 39% of the Student Body that voted, 78% of those respondents were willing to increase their student fees by \$100.00 or more to support a football team; and,
- **WHEREAS,** in addition, a Football Feasibility Committee was commissioned to research and study the possibility of adding a football program at UNC Charlotte, and voted unanimously in favor of creating a NCAA Division I football team; and,
- **WHEREAS,** in addition, Chancellor Phillip Dubois has examined copious amounts of research and completed the due diligence needed for a decision of this weight, and also endorsed creating a football team; and,
- **WHEREAS**, the Student Body of UNC Charlotte remains enthusiastically supportive of creating a NCAA Division I football team as soon as reasonably possible; and,
- **WHEREAS,** the UNC Association of Student Governments, as the collective student voice of the students of the University of North Carolina, is committed to supporting the
